

TOWN OF ROSENDALE TOWN BOARD MEETING DECEMBER 10, 2008

The meeting was called to order at 7:30 pm by Supervisor McDonough at the Rosendale Community Center with the Pledge to the Flag.

Supervisor McDonough asked those present to remain standing for a moment of silence in remembrance of Burt Johnson a long time dog warden and volunteer with the Town of Rosendale who died recently.

PETITIONS: No petitions were presented.

PUBLIC COMMENTS: There were no public comments presented.

COMMUNITY EVENTS: Listed at the end of agenda as Dates to Remember.

MINUTES OF PRIOR MEETINGS: A motion was made by Councilwoman Greene to accept the November minutes as presented; seconded by Councilman Cluen. Roll Vote: 3 Yeses, 2 Excused.

COMMITTEE REPORTS: Councilman Cluen reported that all is fine at the Transfer Station. The Youth Dept. is trying to adjust to budget cuts for 2009; he also reported that Kathy Wade will be staying on as Youth Director. Kathy had taken the tests and interviewed for a Correction Officer position but has decided to remain with the Town. Supervisor McDonough stated that he believes the Youth Dept. will be okay as far as budget is concerned; Kathy has always come through. Councilman Cluen also reported that the Environmental Commission is planning for their annual "Earth Fest" for the day prior to Mother's Day and it will be called "Mother Earth Fest".

Councilwoman Greene reported that the Planning Board has been reviewing subdivisions; they also have been discussing the AT&T tower in Maple Hill. Councilwoman Greene noted that the tower is out of compliance with Code and also with the FCC because navigational lights are out on the tower. AT&T is seeking to renovate the tower but must become compliant before they can proceed with any application. Councilwoman Greene also stated that the tanker truck at a Route 32 commercial property is not compliant with Code; it is against Code to such an expanse of impervious surface; Ulster County Planning Board has never reviewed the project; a second curb cut was made but not authorized. It was stated that Tom Fiore, Building Inspector, issued a permit for work which should have been only a driveway. Supervisor McDonough stated

that he did not believe that Tom Fiore would issue a permit to pave the entire lot; this was probably a presumption on the part of the owner; an attorney for the Town is looking into the matter.

Councilwoman Greene also reported that the ZRC Committee is making progress; they have started to interview consultants; it's going to be a hard decision because they received so many (10) exceptionally qualified proposals; they hope by a week from Thursday to have a recommendation to bring to the Town Board. The Committee negotiating the Police contract is still meeting; eight (8) grievances were filed in on the same day which is hindering the negotiations. Supervisor McDonough has made recommendations to Chief DiBattista to maintain adequate night coverage; Ken Hassett asked about the Police budget; Supervisor McDonough said that when you total "personnel services", "contractual expenses", and then factor in health benefits and insurance which are lumped together for all Town employees, the figure is close to \$600,000. Comment was made that the tax payers need to know that some people may be using the union for personal gain; it seems like retaliation. Supervisor McDonough said that when the contract negotiations started, the grievances started. The question was asked, "are we getting the bang for our buck"; Councilwoman Greene said that if the Officers know the community, they should know that we are "maxed out".
